



## Memorandum of Understanding

### Article 1 - Parties

The following partnership agreement is entered upon between:

European Ageing Network (EAN), represented by Jiří Horecký, President

And

Alzheimer Europe (AE), represented by Iva Holmerová, Chairperson

Hereafter referred to as "the Parties".

### Article 2 – Duration

The agreement is made without limit of time and may be revoked by any of the parties in writing with immediate effect. The partnership agreement shall be reviewed every three years.

### Article 3 – General principles

Both parties agree to strive to build a partnership and cooperation in order to meet their respective goals and agree to support each other collecting and providing specific information on Long Term Care (LTC) services and service providers in member countries.

### Article 4 – Recognition

AE recognises EAN as an important network for European long-term care providers.

EAN recognises AE as the representative voice of people with dementia, their cares and those of national Alzheimer's associations in Europe.

### Article 5 – Information sharing and joint meetings

1. EAN and AE agree to inform each other about their activities and events and agree to promote information on activities of the partner organisation among their members through website, e-mails and at meetings, and to forward communications.
2. While contact databases will remain the sole property of the respective parties, both parties agree to circulate information on conferences and other activities of the other party to their contacts in their respective databases.
3. Once a year, the two organisations shall schedule a face-to-face meeting of high-level delegations of each organisation.
4. Both organisations shall invite a representative of the other organisation to attend their Annual Meeting in an observer capacity.

### Article 6 – Collaboration on Annual Conference

1. Both parties will announce the meetings of the other party on their Internet sites, publications and agendas of meetings.
2. Both parties will waive the registration fees of two representatives of the other party at their respective annual conferences.
3. Both parties will provide exhibition space for a stand of the other party at their respective conferences.
4. Both parties will provide a half page advert in the conference programme or abstract book for the other organisation's conference.



### Article 7 – Publicity of collaboration

1. Both parties may use the logo of the other party and the statement "Partner of ..." on their publications and Internet site.
2. Both parties will provide a link to the other party on their Internet site.

### Article 8 – Collaboration on research, policy, projects and publications

1. Both organisations commit to working together on research, projects and publications that promote person centred dementia care in long term services and will aim to identify European and International funding opportunities where representatives of the two organisations can collaborate and further the vision and aims identified in this partnership agreement.
2. Both organisations may prepare and release common statements and position papers on relevant topics to be communicated to the EU Commission and other stakeholders and will consider setting up a joint working group for the development of such guidelines, positions or statements.
