Outstanding organisations and facilities: Who is the best in Europe?

AWARDS 2018

In 2014 and 2016 EAHSA havel recognised an outstanding organisation and an innovative facility throughout Europe by an EAHSA Award. This time the Award will be open to all members of the European Ageing Network, the joint organization of EAHSA and EDE and will be awarded on behalf of the EAN and the European Centre for Research and Education in Ageing Services (ECREAS).

In 2014 Seniorenzentrum Krefeld, Germany was awarded as the **best facility** for senior care in Europe and the Fédération Nationale Avenir et Qualité de Vie des Personnes Agées (FNAQPA), France, was awarded as the **best provider organisation**.

In 2016 the Heiveld in Gent, Belgium was awarded as the **best facility** for senior care in Europe and "Les Cèdres" in Beaux, France was awarded as **best provider organisation.**

The award is entitled for a period of two years and gives a lot of (international) attention to the winners of this awards.

Therefore, for the EAN/ECREAS Award 2018 there will be **TWO** categories:

Category 1: Best facility in Europe (a facility where residents/clients live and get support and care)

Category 2: Best organisation in Europe (an organization that runs, facilitates or supports provider organisations or advocates the interests of provider organisations).

These two Awards recognize a FACILITY and a PROVIDER ORGANIZATION that demonstrates special or unique leadership, innovation and excellence to the sector.

NOMINATIONS (can be submitted in English, German, French or Italian)

The following should be provided:

- 1. A brief outline of the organization and/or facility, (eg. services, clients, size, history, website, etc.) (100 words).
- 2. Description of what has made the organization and/or facility outstanding and pioneering in your region or country. Examples should be provided (max. 250 words).





- 3. Description of how the qualities of the organization and/or the facility have resulted in a high quality care, exceptional services for the clients/residents and financial benefits (max. 250 words).
- 4. Supply any other information that you consider relevant to this nomination (max. 100 words).
- 5. Explain why the organization and/or facility should be considered for which Award (facility or organisation) (max 50 words).
- 6. Include up to 100 words of your choice to be used for an announcement of your nomination at the presentation event.
- 7. Submit your nomination by the 31st July 2018 to info@ecreas.eu with "Award Nomination" in the subject line.

The award winners will be announced during the Conference on the 13th September 2018 in Prague.

So it is necessary that if you submit your nomination a representative of your organization is present at the conference in Prague.
