200 elderly care managers meet at ANSDIPP conference in Matera (IT)

EAN member ANSDIPP, the Italian association of managers in the social and health care sector, has organised the Matera conference, themed "Evolution of personal care models and health and social care integration in the third millennium: scenarios, prospects, sustainability and uncertainties". The conference was organised on 23-25 October in Matera, Italy and attrackted some 200 elderly care managers from all over the European Union.



With many high level speakers from all over the world, among which Jiri Horecky and Aad Koster of EAN, the three-day conference provided expert insights in the developments and best-practices in modern elderly care.

EAN General Assembly meeting in Matera to agree 2 new working groups

Board and General The Assembly of EAN have met in Matera (IT)along the ANSDIPP conference on 23 October. Both agreed to start two new working groups:on nutrition in elderly care settings and on Prejudices and dogmas in elderly care policies.

EAN also endorsed the memorandum of understanding with Alzheimer Europe. Both organisations commit to working together on research, projects and publications that promote



person centred dementia care in long term services and will aim to identify European and International funding opportunities where representatives of the two organisations can collaborate and further the vision and aims identified in this partnership agreement.

Working group Nutrition in elderly care

Working group Prejudices and dogmas

The aim of the working group is to create guidelines about nutrition care in social services facilities for elderly and to provide a practical toolkit for elderly care organisations and its management. The guidelines should content key principles, procedures and processes, good practices examples and solutions. The working group will be composed of EANmembers, the European Federation of the Associations of Dietitians (EFAD), DSM and other stakeholders. To tackle misunderstandings and false rationales in elderly care policies, EAN will identify and rectify prejudices and socalled dogma's that dominate today's elderly care policy making in Europe. EAN members will discuss different dogma's on a national and European level and produce a new set of policy basics for elderly care. EAN will so help policy and decision makers to better understand today's elderly care and to formulate new and innovative policies.

EC publishes study on social protection expenditure and its financing in Europe

The newly issued synthesis report produced by the European Social Policy Network (ESPN) shows that, while the Great Recession increased the need for spending, costcontainment policies have kept down both expenditure on old-age pensions and healthcare, while the share of social contributions in the funding of social protection has tended to decline, compensated by an increase in the share of funding from taxes.

This shift in the sources of financing, however, seems more a consequence of conscious efforts by governments across the EU to keep down or reduce taxes on employment, especially employers' contributions, than of any erosion of the base – i.e. income from employment – on which contributions are levied.

The synthesis report produced by the European Social Policy Network (ESPN) examines the changes which occurred in expenditure on social protection and the sources of its financing over the period 2005-2016.

Over the past few decades, pressure from demographic ageing and changing patterns of work, as well as the Great Recession (2008-2010) and the fiscal consolidation policies which followed it, have challenged national social protection systems in their role of ensuring adequate support to all those in need.

The European Social Policy Network (ESPN) provides high quality and timely independent information, advice, analysis and expertise on social policy issues in the EU, in neighbouring countries and in third countries. It was established in 2014.

In particular, the ESPN supports the Commission in monitoring progress towards the EU social protection and social inclusion objectives set out in the Europe 2020 strategy, including the European Pillar of Social Rights, and in the European Semester

EAN proposes communications strategy for SecureHospitals project

Karel Vostry, EAN representative in the SecureHospitals project, has presented the communications and dissemination strategy at the last meeting in Barcelona. The strategy will help spread the results and outcomes of the work carried out by the European consortium.

At the Barcelona meeting, participants also discussed the upcoming activities, including the MOOC, summer school, workshops, and dissemination activities, all of which include the contribution of all partners.

SecureHospitals seeks to aggregate knowledge on existing cybersecurity practices across healthcare organisations, analyse, elaborate and disseminate the information as a means of achieving common understanding among practitioners on best practices and strategies. Cybersecurity needs to become an integral part of the organisation s strategic and policy documents, not as a formality but as good practice. The surveyed sample shows that hospitals might be a small step ahead of the social care organisations in understanding the potential impacts.

Cybersecurity is an ongoing and fluid effort, as new risks and threats emerge relative to the exponential growth and reach of the technology, processing power. Moore's laws suggest that the processing power doubles every 18 months, however the cycle is much faster and accelerating now, and innovative approaches, such as artificial intelligence.
