








## A new start

- New composition of the EU institutions
  - EC: a Commissioner for Democracy & demography
  - EP: an Intergroup for Intergenerational solidarity
  - EC Workshop and announcement of a Greenpaper on Ageing
- EAN 2019 Elections Memorandum
  - "Less medical, more social"
  - Call for a Workforce agenda 2030
- Going concern:
  - Brexit
  - EU Pillar of social rights: Directives Life-work balance, predictable and transparent working conditions, minimum wages







## Greenpaper on Ageing

- Announced in Jan 2020, published in Jan 2021
- Aims at launching political debate on ageing and discussing the options
- The proposals include:
  - Ensuring quality education opportunities in rural and remote areas for the youth
  - Promoting lifelong learning to ensure a large enough workforce in the healthcare and long-term care sectors for older adults
  - Encouraging volunteering activities among older adults
  - Combating old-age poverty by acting on older adults' pension schemes
  - Promoting healthy ageing
- EAN input for consultation
  - EAN position paper
  - EAN Vision LTC2030










# The forgotten, Green deal (Jan 2020)

- Stand-still for EU policies
- European Green Deal: transform the EU into a modern, resource-efficient and competitive economy, ensuring:
  - no net emissions of greenhouse gases by 2050
  - economic growth decoupled from resource use
  - no person and no place left behind
- Potential impact for (health) care:
  - Climate-smart healthcare
  - Safer chemicals
  - Safer pharma
  - Sustainable procurement
  - Sustainable food, buildings and waste management








## The second Covid wave (Autumn 2020)

- Resilience and Recovery facility (RRF)
  - key instrument at the heart of NextGenerationEU to help the EU emerge stronger and more resilient from the Covid crisis
  - €672.5 billion in loans and grants available to support reforms and investments undertaken by Member States
- Member States follow EC
  - Shift of initiative and power
  - EC puts stringent criteria on Member States







## The European Care Strategy (2021)

- Unexpectedly announced in State of the Union by Von der Leyen
- Support the implementation of the principles of the European Pillar of Social Rights
  - gender equality
  - work-life balance
  - childcare and support to children and
  - long-term care
- Published in Summer 2022
  - Mixed reactions
  - Role of Member States?
  - Social services and elderly care better off?







## SESK – Social Services Helpdesk (2021)

### ESF funded project

- aims to finance the building blocks for a Social Services Helpdesk that will have two main priorities:
  - to support social services in accessing and using EU funds and
  - to help Managing Authorities use EU funds to finance quality interventions in the field of social services

### Main objectives:

- Promoting capacity building and awareness raising about ESF+, ERDF & React EU (and other relevant EU funds) about how such funds can better support effective social services interventions
- Facilitating and simplifying the use of and access to EU funds for social services
- Facilitating exchange and cooperation between Managing Authorities, social services, and the European Commission (EC) to ensure that funding priorities are based on an assessment of social needs and target effective evidence-based social services interventions.





The workshop that will take place is a part of the Helpdesk project, in which the EAN is a partner, as part of Work Package 5, which deals with technical and policy guidance. There will be a total of 10 sectoral workshops as a part of this package, 2 for each of the sectors, with EAN being responsible for the Elderly care sector. We are using the opportunity of the EAN general assembly taking place in April, when the first workshop is to take place, to host the event live, with the second workshop, which will be held in October, probably taking place online.

The workshops are intended to provide Technical Guidance as to how to maximise the social impact of ESF+ & ERDF for effective interventions in social services – in our case in the Elderly care department.

More specifically with the organisation of the workshop the partners of the consortium seek to:

- generate a broad and common understanding of the key issues and challenges of designing
  policies, programmes and measures in a way that their implementation can be supported by
  "exploiting" the ESF+ and ERDF;
- Improve the capacities of the Managing Authorities in the managing, planning and implementation of ESF+ and ERDF as well as of the identification of policies, programmes and measures in a manner that they can effectively support social services sectors in accessing those funds:
- Improve capacities of social services to get access to ESF+ and ERDF to use them and for the
  implementation of EU Social Policy initiatives and frameworks including the European Pillar
  of Social Rights, the European Strategy for the Rights of Persons with Disabilities, the Social
  Economy Action Plan and the European Care Strategy;
- Address the needs, issues, opportunities and challenges that are the root cause for the use
  of ESF+ and ERDF and that can be addressed by using these EU funds;
- Look forward, what the MAs can finance and what social services would expect and see as relevant and prioritary to be financed for the future;
- Outline what MAs could fund under the ESF+ and ERDF frameworks;
- Disseminate knowledge, share best practices and findings from the surveys run in the context of the project as well as the evidence collected at the events organised.

Mdina is a fortified medieval town, dating back to more than 400 years, enclosed in bastions, located on a large hill in the centre of Malta. The town was the old capital of Malta, and with its narrow streets, few inhabitants and beautiful views over the Island it is truly a magical town. It was home then, as now, to Malta's noble families; some are descendants of the Norman, Sicilian and Spanish overlords who made Mdina their home from the 12th century onwards. Impressive palaces line its narrow, shady streets. Mdina is one of Europe's finest examples of an ancient walled city and extraordinary in its mix of medieval and baroque architecture. Like nearby Mdina, Rabat played a major role in Malta's past and is a prime source of its cultural heritage.
