#### a) Care Strategy 2022

Marcel informed the GA about the published EU Care strategy. A few slides in the main presentation.

The EU care strategy was announced September 2021 and is linked to some other relevant EC initiatives. There was an open consultation, to which EAN separately and via Social Services Europe has reacted.

The EU Care Strategy in fact consists of one communication, setting out the lines of the strategy, and two Council recommendations (1 on childcare and 1 on LTC). The EU Care Strategy relies on the actions undertaken by the Member States. It is on national level that the Strategy should get form. This delegation to MS is somewhat a disappointment. Only for funding of national plans, the EU can come in. For the funding, the EC suggest the use of the Recovery and Resilience Funds.

For EAN members it is therefor important to closely follow-up the national activities and planning. In the discussion that followed, it was suggested to formulate an EAN position paper and to draft a general letter to national governments, to be adapted by the national EAN delegations. EAN, within Social Services Europe, will also react on it.

Freek Lapré presented current situation of ECREAS and mentioned main goals of this platform and following steps. The presentation of Freek enclosed to these Minutes as part of the main PDF.

Main points and decisions:

- To postpone the signing of the agreement because the founding of a legal entity in Slovenija has slowed down because of involvement of the Slovenian Government that is very much in favor of a knowledge centre like ECREAS

- The working relationship with Vilans, the long-term care knowledge centre in the Netherlands is active

-The survey results will be used to give a direction of the activities of ECREAS in collaboration with EAN

Elena Weber presented us current AGE platform activities. Mandates of Elena and Pascal will terminate in 11/2023, EB has to decide in Malta who will represent EAN in AGE Platform
