#### 01. Welcome by president of the EAN and the representative of ActiZ

- Mr. Jiří Horecký (JH), president of the EAN and Mr. Wouter van Soest the CEO of ActiZ welcomed delegates of the member associations and the guests as well in Utrecht at the GA meeting
- The participants were given a short presentation by ActiZ

#### 02. Agenda proposal & Minutes from the last GA – Prague 9/2018

- Proposed agenda (annexed) of the GA meeting was approved
- GA members had no objections or remarks to the Minutes of last GA meeting in Prague (15/9/2018) and adopted the Minutes

#### 03. President and Board activities overview

- President Horecký informed the participants about his and EB activities and agendas and about the plan for future months

- Vincenzo Paolino added one activity a virtual SKYPE round table with the Global Ageing Network on topic The role of registered nurses in LTC (April 2, 2019)

- ORPEA Germany Mr. President is now in touch with them, they are very interested in becoming a member. The EAN needs a strong member in Germany
- SYNERPA France Mrs. Florence ARNAIZ-MAUME briefly presented SYNERPA, a big private social care provider from France. SYNERPA is also very interested in becoming a member of EAN, Mr. Champvert and Mr. Sapy were in touch with them in the past

#### 05. Alzheimer Center, Israel

- Mr. Eliash Nitai and his wife presented us The Israeli Alzheimer Medical Center
- The presentation in PDF is attached to these Minutes
- Alzheimer Center Israel is ready for cooperation, for instance in projects etc.

#### <u>06. EAHSA dissolution – current situation – Aad Koster</u>

- Aad Koster informed us about the last meeting of EAHSA (early in the morning the same day)
- The AGM decided about all the steps needed for EAHSA's final dissolution (with enough of votes and proxies)
- All decisions taken are in the main presentation

#### 07. Financial overview, Membership fees 2018 & 2019, Budget 2019, GAN fee 2019

- Annual financial report 2018 and budget proposal for 2019 were sent along with all the materials earlier to members
- The net surplus of 2018 is +15.841,81 EUR
- We went through the most important cost and revenue items, the figures in the main presentation are not so detailed as the real numbers in Beatrix's report, which was sent earlier
- JH thanked to all our partners Paul Hartmann, Sodexo, Arjo and ActiZ
- JH also excused the EAN treasurer Beatrix Kaserer from today's meeting and thanked her for her
  work for EAN. In future we have to talk about the possibility to pay a professional accountant
  because it is lot of work for Beatrix and she is doing all the work as a volunteer
- No profit for EAN from the Congress in 2018, there was only a really small profit for APSS ČR
- Arja Kumpu presented the auditor's report of 2018 (see attached)
- JH thanked both auditors (Arja Kumpu, Edgar Führer) for their work

The Financial report of 2018 and the Auditor's report of 2018 were approved unanimously.

#### Budget 2019

- We went through the most important cost and revenue items for 2019, the proposal was sent earlier to all members
- JH informed us about EAN financial visions for the next year
- We discussed in more detail the EAN trade mark registration, ECREAS, GAN membership fee and Brussel lobbyists cost for 2019

The budget proposal of 2019 was **approved** unanimously.

#### 08. EAN auditors for the next financial year

- Arja Kumpu and Edgar Führer were approved unanimously as auditors of EAN for this year.
- JH thanked them once again for their responsible work

- We received three applications for EAN congresses in the future: For 2020: LARES Spain and ADIV Romania, for 2022: Lebensweltheim Austria
- Executive Board of the EAN decided to support LARES for 2020 and Lebensweltheim for 2022
- JH and Karel Vostrý had a meeting with LARES last days
- We have to start to prepare the contract between EAN and LARES, also the congress committee and Plan of action
- The representative of LARES Mr. Antonio Molina Schmid presented the main ideas for the congress in Madrid 2020, they have been organizing the congresses for many years and usually they have around 600-700 participants. They would be very pleased to organize the congress in 2020 together with EAN
- Mrs. Montse Llopis from ACRA (SPAIN) fully supported LARES as congress organizer
- The representative of Lebensweltheim Mr. Markus Mattersberger informed us very briefly about Lebensweltheim's plans for the congress in 2022, they want also to combine this congress with their national congress, they usually have around 400-500 people

The General Assembly decided <u>approved</u> unanimously to organize the EAN congresses in cooperation with LARES in 2020 and with Lebensweltheim in 2022.

#### a. SecureHospitals.eu

- Our role is consultancy and dissemination, Karel Vostrý is working in this project
- Our budget is 110.000,- EUR for 26 months
- No financial participation of EAN

#### b. EldiCare

- We are still waiting for finishing of administration steps to change the partnership from EAHSA to EAN
- The main theme of the project is skills and education of co-workers in LTC
- The first meeting took place in Athens in November 2018, Aad Koster and Marcel Smeets represented EAN (EAHSA), the second project meeting took place in Malaga in April 2019 and Mr. Ondřej Folk from CZE took part

#### c. Erasmus+ EDE certificates

- the aim of this project is to change the curriculum of EDE certificates
- Edgar Führer is working for this project in the name of EAN
- All participants are requested to fill-out on spot the paper form about their education needs

#### 16. EU matters (Marcel Smeets)

#### a. Mutual learning - EC Platform on LTC

• EAN has been invited for two sessions of the EG EMPLOYMENT initiated Mutual Learning Seminars. These seminars are meant to provide input for the new European Commission after the European elections. The fact that EAN has been invited can be seen as a recognition of EAN's position as EU representative of the sector and as an excellent way to actively shape the EU LTC agenda. The first meeting was about stock-taking and was attended by Jiri Horecky. The second session was about Workforce and was attended by Marcel Smeets. Both sessions were introduced by an issue-specific

report. At both sessions EAN was able to present the EAN LTC2030 report and the various position statements that have been drafted earlier.

- b. Transparent and predictable working conditions
- c. Work-life balance directive
- The European institutions have reached agreement on the Work-life balance directive and on transparent and predictable working conditions. Both initiatives are a part of the so-called European Pillar of Social Rights. This program is meant to accelerate social policies in the EU. Although the policies are heavily inspired by the new digital/platform economy and the new jobs, they also have strong implications for the LTC sectors.

#### 17. AGE Platform (Pascal Champvert, Elena Weber)

- Elena Weber is representing EAN in AGE Platform, she presented us the news from this European organization
