- 6-9 June 2024
 - All Member States elect their representatives (min 6, max 96) from Thursday to Sunday
 - Proportional votes
 - Max 750 MEPs, exact number to be decided before elections
 - National parties join political groups (min 23 pax, currently 8 groups)
 - Political groups may form Intergroups (to be negotiated)
- After the elctions
 - 1st session: President and political groups
 - 2nd session: election of President European Commission
 - Later: approval of new members of the European Commission



Preparations

- Political groups are preparing differently and quite secretely
- They all work on "euromanifesto's" or very vague and general electoral programs because:
 - Still the domain of national politics
 - National constituencies and national competition
 - Very few transnational and structured political grouping

How to influence

- Formal and informal (Manifesto drafting committees, contacts, secretariats)
- Online consultations
- Town hall meetings
- Electoral congresses

- Call for
 - EU recruitment and retention strategy
 - Focus on health and social care
 - Common skills framework



Digitalisation – Call for a Digitalisation Strategy

- Starting point
 - EAN Digital Care Summit, Malta 2023
 - All Member States face similar challenges (data availability and exchange, interoperability, deployment, roll-out and scaling, funding, lack of vision)
- Call for
 - EU data strategy for health and social care
 - Skills and training, both staff and older people
 - Common quality framework and promotion research & innovation



- Care pathways Call for a EU Care Vision
- Starting point
 - EU and national policies focus on health (hospital) care, not on social care
 - There is no holistic older people's care vision
- Call for
 - EU vision for health and social care
 - Skills and training of staff
 - Common quality framework and promotion cross-sectoral provision and financing



- Funding Call for a EU Care Funding Framework
- Starting point
 - All Member States face need of massive investments in care
 - The mix of public and private funding is vague, opaque and not regulated
- Call for
 - EU funding framework to clarify rules of Internal market and investments in health and social care
 - Set clear rules of conduct to guarantee quality, impact investment and social entrepreneurship
 - To open up for private initiative and funding, while maintaining quality care






