## Looking back at the Global Ageing Congress on Long-Term Care in Boston



As President of the European Ageing Network, I had the honour of joining leaders in ageing services from more than **20 countries** at the 2025 Global Ageing Congress on Long-term Care in Boston. This exceptional gathering—held in conjunction with the Global Ageing Network Biennial Conference and the LeadingAge Annual Meeting—once again proved that when the global community comes together, the impact resonates far beyond the conference halls.

As the joint conference opened on 2 November, Global Ageing Network Board Chair **Vic Rayner** and LeadingAge President and CEO **Katie Smith Sloan** welcomed the international community with a message I deeply share: our challenges may differ in form, but not in essence. Ageing is universal; our work must be equally united. Their words captured exactly what we, in Europe, have long believed: progress in ageing care must be global, interconnected, and continuous.

Throughout the week, International Perspectives sessions connected experiences from Australia, China, India, Kenya, Belgium, and many more. We discussed age-friendly cities, workforce pathways, AI ethics, data collaboration, and community-based care. Each topic reflected the same truth: diversity strengthens innovation.

As I left Boston, I felt renewed energy and conviction. The conference theme, "**Ripples of Impact**" is more than a slogan—it is an accurate reflection of what global cooperation can achieve. Every shared idea, every connection, every innovation sends ripples that strengthen the lives of older adults across the world.

Final EAN report on Funding to be published in January 2026

More than a year and a half ago, the **Funding Working Group** began exploring options for maintaining **adequate funding for elderly care in the future**. Due to the ageing population, demand for care, support and suitable housing for the elderly is increasing. At the same time, the **limits of public funding** are becoming apparent.

The working group has examined the possibilities of combining **private funding with public funding.** What preconditions and principles are important in this regard? And what forms of private funding exist in European countries? The working group has organised several meetings to further elaborate on this. The experiences of members with various forms of funding have also been discussed at various EAN member meetings. After the report is published next month, it will also be presented to **various stakeholders** in the European Union. The report also supports EAN members in discussing this topic with their stakeholders in their own countries.

## **Project Highlights**

#### **WELL CARE General Assembly Meeting in Copenhagen**



The third General Assembly meeting of the WELL CARE project took place **on 2–3 December 2025 in Copenhagen**, hosted at Hotel Ottilia. Project partners from across Europe came together to review progress, reflect on feedback from the European Commission, and define priorities for the third year of implementation.

The first day focused on project progress and decision-making within key work packages, including WP2, WP3, and WP4. Discussions addressed completed tasks, upcoming deliverables, and strategic alignment across the consortium. Participants also reviewed outcomes from the Technical Review and discussed recommendations for the next phase of the project.

On the second day, attention shifted to project management, national BLN activities, dissemination, sustainability, and scientific communication. The European Ageing Network (EAN) was represented by Karel Vostrý, Director of EAN and Project Manager, and Vojtěch Mericka, Researcher. The meeting concluded with a shared commitment to strengthening collaboration and maximising the project's impact on long-term care systems across Europe.

# Building Competency and Recruitment Pathways for Long-Term Care in Europe (B-Care)



Europe's rapidly ageing population is creating unprecedented demand for long-term care services, yet the sector faces critical workforce shortages. By 2040, an additional 13.5 million care workers will be needed to maintain current care ratios. **LaMP** (member of EAN) is implementing the B-Care project with the aim of laying the technical and institutional foundations for future cooperation on long-term care labour mobility.

The B-Care initiative, running for 10 months until May 2026, targets four EU Member States (France, Greece, Ireland, and Malta) and four partner countries (Morocco, Egypt, Bangladesh, and Pakistan). The project addresses a fundamental challenge: while Health Care Assistants (HCAs) form the backbone of aged care delivery, the profession has limited recruitment pathways and lacks a standardized reference framework.

The project pursues two key objectives:

- · First, developing a common competency framework for HCAs, to establish shared standards for training and skills assessment between selected EU and partner countries. This framework will approximate training expectations and create transparent recruitment criteria for employers.
- · Second, building on this, outlining the design of a mobility scheme for potential future implementation that promotes fair and sustainable care worker migration.

B-Care will create a practical blueprint for structured labour mobility. The initiative brings together public and private stakeholders to develop solutions that benefit workers seeking employment opportunities, employers struggling to fill vacancies, and societies requiring sustainable care systems.

LTCF Het Heiveld awarded at the European Parliament for Green Elderly Care





**LTCF Het Heiveld** (public service **City of Ghent**, an EAN member, Belgium) was honoured with a prestigious award and prize in the European Parliament in Brussels for its efforts in enhancing the quality of life of its residents. The New European Bauhaus Prizes 2025 were awarded on September 30th.

Het Heiveld was runner-up in the category "reconnecting with nature" and selected out of hundreds of projects all over Europe. **Green Elderly Care** is a project to enhance the quality of life for long-term care residents by creating a green, biodiverse environment that fosters social interaction, participation, and belonging. **Scientific research confirms** that meaningful nature-based activities, biodiversity, and strong community ties all contribute to well-being.

The project is **inclusive and participatory**, ensuring all residents – regardless of physical, psychological, or social needs – can benefit. **Active involvement** of residents, families, and staff strengthens autonomy and decision-making.

# Bridging Health, Care, and Technology in Europe's Longevity Transition

Age-It scholars Marco Albertini, Filippo Cavallo and Antonio Cherubini have published a new article highlighting the urgent need to better connect **health care**, **social care**, **and technological innovation** in response to Europe's ageing societies.

Drawing on recent research and expert dialogue, the authors argue that fragmented systems and isolated interventions are no longer sufficient. Instead, they call for **person-centred, integrated approaches** that support older people, recognise and empower informal carers, and ensure that technology serves people rather than replacing them.

The article also emphasises the importance of prevention across the life course, reducing territorial inequalities in care, and closing the gap between research evidence and policy implementation.
