Challenge your Region on its approach to an ageing population!

The E.D.E. (represented by Angela Cluzel) and other partners from *AGE Platform* were invited to a European event «JOINT PUBLIC HEARING» organised by the Committee of Regions on 9 December 2008 in Brussels. The topic was "Longer and Healthier Lives – a Challenge for Local and Regional Authorities". Sven Matzke from the DG Employment and Social Affairs presented the 2nd European Demography Report and outlined five key policy directions: promoting a demographic renewal, promoting the employment, promoting a more productive and ageing society, receiving and integrating migrants, ensuring the sustainability of public finances.

The participants from the *Platform AGE* reminded the speakers that the responsibility of demographic ageing is not only a task for the Member States and the EU, but also for the vast majority of European Regions that are confronted with a rapid population decline.

The Regions are recommended to offer services that are adapted to the needs of older people, such as accessible public transport, housing and infrastructure, ensuring the quality in health and long term care services, promoting an active citizenship and cross-generational initiatives, increasing social participation and involvement of older people in community life as well as valorising their role as carers for family or relatives.

The E.D.E., as a member of *AGE Platform*, invites each of its members to make contact with their Regions and remind them of this Hearing at the Committee of Regions in Brussels.
