## Between association work and profitability – the diverse activities of the Czech Association

The history of the Czech Association Asociace Poskytovatelu Socialnich Sluzeb Ceske Republiky (APSS CR) goes back to 1991, when a couple of homes for the elderly decided to start up an umbrella organisation. Today we have more than 670 members and provide 1,500 social services. The Czech Association has had several key moments. One was the decision in 2006 to open the Association to other providers of social services, not just homes for the elderly. Another was our so-called professionalisation, when we went from being a group of volunteers to having 9 employees providing services to our members.

One of our main activities – apart from lobbying on behalf of social services – is putting out the

professional magazine "Sociální sluzby" on social services. The country's most widely read and important monthly publication in its field, the magazine has allowed us to influence public opinion in certain cases. Another key activity is organizing conferences. In 2010 we will prepare 10 conferences with a total of 3,000 participants, on palliative care, nutrition in care homes, guality and financing of social services and home care service in the Czech Republic, among other subjects. This year the Czech Association established its own training institute with 15 training centres – one in every Czech and Moravian region. The training institute has more than 100 lecturers on contract, and offers training programmes on a wide variety of social care services.

It will inform you about current developments within the European care centres as well as about projects of the E.D.E. and its member countries. The E.D.E. also intends to adopt a position on real issues in European politics in the context of care for the elderly.

## Care Services Centre for the Elderly in Subotica a positive example of a socially responsible institution

Gerontološki centar: socijalno – zdravstvena ustanova za zbrinjavanje odraslih lica, the Care Centre for the Elderly in Subotica (Serbia/ Vojevodina), is a social care institution that incorporates three homes for the elderly accommodating a total of 530 beneficiaries. Additionally, an elderly home care service has been developed within the Institution since 1971, which now employs 79 people. This department has five clubs for the elderly (day centres) – two of which are located in the surrounding rural areas – numbering 4,200 members.

The home care service department provides services to approximately 1,000 beneficiaries living in all areas of the City, a characteristic that makes the Care Services Centre in Subotica unique among similar institutions operating in Serbia. It is unfortunate that other big towns and cities do not have the necessary capacities or capabilities to provide home-based services to people living in rural or remote areas.

Our Institution is able to provide these services due to an ongoing Public Works Project financed by the Provincial Secretariat for Work, Employment and Gender Equality (PSWEGE). The first project of this kind was approved in 2006, when 13 people were initially employed on one-year contracts. By 2009 they were granted full-time employment on the basis of their professionalism and dedication. On the strength of our positive track-record we were eligible for a new programme of the PSWEGE in 2009, and received funding for an additional 72 additional employees. The project's duration is six months, with a total budget of over 150,000.00 euros.

#### **Consequences of the new care sector legislation in Hungary**

On the 1st of January 2008 a significant change occurred in the Hungarian legal system with regards to care for the elderly. According to the new law, only those in need of 4 hours of care-taking or more per day may be lodged in care homes for the elderly. The only exceptions to this ruling are spouses, partners, brothers, sisters and disabled relatives who have been living together with the care recipient for at least a year. The sort of care needed is determined exactly by an independent expert committee, which also issues a binding expert opinion.

As a result of the new ruling, the system of requirements for elderly people living in care establishments has been greatly transformed. The upshot is that the average health of care recipients in our institutions is steadily worsening. A growing number of residents are disabled, many have dementia and are almost entirely dependent on others for their well-being. Equipped as they are today, most establishments are only partially prepared to provide the specialized care needed under the new law.

The legislation fails to account for the fact that the increased number of tasks do not tally either with personnel conditions or the number of professionals required. Taking care of disabled people whose health is considerably deteriorated exerts far greater financial pressure on the management of an institution, since the law fails to provide for increased funding. In all cases needing less than 4 hours of daily care, directors are obliged to inform applicants of what kind of home services are available to them, and how these services may be rendered.

### The ESJN – recognizing the professional merits of our colleagues

The ESJN – EEsti Sotsiaalasutuste Juhtide Nöukoda, or Estonian Association for Directors of Care Homes, was established in 1987 under its first president Valter Koppel. Active collaboration with the E.D.E. began in 1991. The main supporters were Valter Koppel and Mrs. Siiri Oviir, then Minister of Social Affairs of Estonia. In 2005 the General Board of the E.D.E. visited Estonia. The host was Egon Siimson, president of the ESJN from 1995 to 2008. Since 2008 Vambola Sipelgas has been responsible for managing our organization.

The second factor is training. To face problems such as poverty, unemployment and depression we have to assess our possibilities and try to apply a broad range of strategies. To bring more transparency and efficiency to our everyday work in care homes, we are working on guidelines for assessing clients' needs and standards in our care homes. Government and municipal support is necessary in this task. We also offer our members various training possibilities. For example, the Baltic Conference of Social Care will be held in Estonia in May
